Please note that the schedule for these days is different than in the past due to my daughter only arriving back from the International Student Convention in the USA, late on Sunday, 18 June, and my official Assessment visit from the National Office that has been scheduled for Monday 19 June. I encourage **ALL HOME SCHOOLS** to attend the Home Educators Days each quarter. There are a number of home schools who do not attend the Home Educators Days each quarter. This could unfortunately result in important information not reaching each home school, or training re the RNCS, CASS, or other important matters being missed.

There is unfortunately no time to discuss the matters addressed during the Home Educators Days at each assessment visit at your home, as this visit is meant for assessment purposes. The Home Educators Days have therefore been scheduled for fellowship, training, discussions, etc. that there normally would not be time for at an assessment visit. Therefore the H/Edu. Days have been scheduled from 09h00-13h00.

According to the contract each home school has signed with the ACE National Office, it is required that quarterly Regional Meetings or Home Educators Days be attended by each home school in order for open channels of communication re information, etc.

ACE therefore accepts that I see each home school twice per quarter – once at your home, and once at the Home Educators Day. The attendance of the H/Edu Days are also recorded on your Assessment Visit Forms that I complete and send to the ACE National Office at the end of each year. These two trips (Assessment Visits and H/Edu Days) through the Western Cape each quarter, are also included in your Quarterly Account from the WCHEA, and should you not attend the H/Edu days, you are in effect paying for a service that you are not making use of.

Thanks for considering this information, and making an effort to attend the H/Edu Days for your own benefit.

ASSESSORS TRAINING COURSE

I sent an e mail on 15 March to all hon schools (who possess an e mail address) this training course. Up to today I have only had eight replies out of the 52 hon schools who I e mailed.

The ACE Assessors Training course is a accredited training course where the relevance of CASS, the Learning Outcomes, Assessment Standards, etc. at the completion of the forms will be presented. This is a two day training course that will be presented in Worcester on 29 and 30 March and the cost R2000 per delegate.

I have had a request from one of the hon schools, that I attend this training course and that I will then present a training course/s to all the home educators afterwards. I will then obviously ask a fee to cover my training, petrol cost accommodation (where necessary) etc. but this will work out significantly cheaper for each home school. Some home schools have with the completion and understanding for instance the CASS forms, and the request was that I therefore attend the training and then train the home schools interested.
