AXEL – ADMINISTRATORS TRAINING

During the school holidays after the second quarter, from Monday, 9 July to Friday, 13 July, I will be attending the ACE Administrators Retraining Course.

This is a compulsory Training course that I must attend every five years, but I am blessed that the Training Course will for the first time be presented in Laingsburg by the ACE Area Managers, and not in Durban as in the past.

FEEDBACK ON AXEL'S ASSESSORS PORTFOLIO

I have just phoned ACE (26 March @ 09h30) to get some feedback on the Assessors Portfolio that I submitted on 15 October last year. It seems that there are delays on the part of the Education SETA. I have not had any feedback at all with regards to the Portfolio, but will keep you posted as soon as I receive feedback.

PAYMENTS HOST FEES AND ORDERS

Please take note that - as mentioned on the back of this newsletter – the WCHEA has two bank accounts. The first account is for payment of Host Fees mentioned on your quarterly account enclosed with this newsletter. The details of this account are:

WCHEA, ABSA CERES, CHEQUE ACCOUNT, 4056755308, BANK CODE: 334 107.

The other account is for ALL PACE ORDER PAYMENTS and the details of this account are:

WCHEA ORDERS, ABSA CERES, SAVINGS ACCOUNT, 9111953305, BANK CODE 334 107.

A reminder that your account (not the account of customers with a special fee structure) is “loaded” with an extra R50 per quarter, which you may subtract if you pay the Host Fees within the first month of the quarter. Should you pay the full account before the end of the first month of the quarter, I will assume that you have decided to bless me with this R50. **Also a reminder that payment for all orders should be made as soon as you receive the amount.** I need to be able to pay ACE within 48 hours of placing all orders. A delay in my

payment to ACE (because payments of order Home Educators to me are late) causes even orders to be delayed at ACE. They will only disburse order once I have settled my account with them.

Thank you for your full co-operation in this Home Schools who continue to pay orders late contacted and advised that future orders postponed and ordered at the next order date payment does not reach me before I order from That could cause a delay of two weeks or more.

CFAM/OBEST TESTS

I am planning to conduct CFAM/OBEST again this year possibly at the end of Sep Remember that these tests are a requirement ACE.

Depending on the response from all Home Educators will again travel through the Province and at these tests at four different venues – Cape Laingsburg, Hartenbos and Robertson. The involved will also depend on the amount of being tested, as I will also have to recover my costs. These tests will be R120 per student, if children.

All students in Grade three, six/seven and nine write these tests, although you are welcome to your students every year to see their progression on a yearly basis. There are currently students within the WCHEA that are enrolled Grade levels. I will accept that these students tested this year. **IF FOR SOME REASON YOU NOT WANT YOUR CHILDREN TO TAKE THESE TESTS, OR YOU WANT ALL CHILDREN TO TAKE THESE TESTS, PLEASE LET ME KNOW, AS THE COST OF THESE TESTS WILL BE ADDED TO YOUR ACCOUNT AT THE END OF THE SECOND QUARTER.** Should you need more info about these tests, mail me and I will send you an explanation via e
