## ASSESSMENT VISITS

Just a friendly reminder that I will always assess the following at the quarterly assessment visits scheduled at your home.

- Goal Cards – number of pages completed daily, realistic goals set, Changes to goals made by parents in green ink, repeated goals, gaps in goals, neatness of goal card and ruler to be used when crossing off goals, goals should be written in blue pen.

- Goal Check Report Forms – Attendance, daily activities like ST, PT, comments about daily routine, sport, orals, scriptures memorized, week dates.
- Supervisors Cards – Terms indicated by colouring, PACEs issued and Tests scores should also be recorded., record of PACE Prescriptions and stock should be on the S.P.C.
- PACEs – Checkups and Self Tests to be initialed by parent, Checkup scores 80% and Self Test scores 90%, Corrections and cross referencing completed, Spot checking of PACEs by parents, Scoring Procedures by students (Red Pen), Neatness and Handwriting.
- PACE tests – Check scoring procedures, Corrections and Cross Referencing completed.
- CASS forms and projects – Accuracy of Marks allocated, Oral/Book Reports completed, Student Portfolio.

Please remember to have a copy of the following documents ready at every visit :

- Goal Check Report Form of the previous quarter.
- Supervisors Progress Card up to the visit date.

## HOST FEES ADJUSTMENT

Once again, I consulted with Mr. Anton Cilliers regarding the financial statements, well being, etc. of the W.C.H.E.A. The idea is to be financially and spiritually accountable and transparent to a relevant person who loves the Lord, has a heart for Home Schooling and who was willing to help and be totally honest with me regarding the business side of the WCHEA.

I presented him with the budget, the Financial Statements, etc. Mr. Cilliers gave me some very practical advice in order to stay totally transparent and relevant during 2008.

Taking into consideration that petrol has increased considerably, the cost of communication & stationery has increased, and also reading through the Questionnaires that I sent out to you regarding the service delivery of the WCHEA, I would therefore like to inform you an increase of only 7% will apply from January 2008. Therefore my structure will be as follows:

Host Fees 1 student – R505 per quarter – 7.4  
Host Fees 2 students – R695 per quarter – 6.9  
Host Fees 3 students – R795 per quarter – 7.4  
Host Fees 4 student – R845 per quarter – 7.6

Remember that you will still be charged R50 family per quarter more than these fees, but you may subtract this R50 if the full account is paid within the first month of each quarter.

Admin Fees will remain at R10 per student quarter. These fees will ensure that each student receives the following forms from me :

- Goal Check Report Form – one per quarter
- Supervisors Card – One per year
- Star Chart – one per year
- Goal Cards – 5/6 per quarter
- Oral Report Form as needed
- CASS Record Card – one per year.

I would like to thank everyone for their support, blessings and fellowship during 2007. It has been a challenging year, but I can truly say that the Lord has once again been faithful in supplying all our needs.
