Mandatory Scheduled Assessment Visits

Each quarter, I email my schedule for the whole quarter to all the home schools in order for you to be informed as to my whereabouts for the entire quarter. As you are aware, I travel through the whole Western Cape twice a quarter. The first time, I am doing the assessment visits at

each home schools' home in a round trip from Monday to Friday, while the second time, I travel to five venues within one week in order to facilitate the Quarterly Home Educators Days. These days are each scheduled on a specific day, and afterwards I travel to the next venue for the Home Educators Days scheduled for the following day.

It has become quite a challenge to me when home schools are unable to see me at the scheduled time set for the quarter. During the last quarter, I have had more cancellations than ever before. It also presents a challenge to me when a cancellation occurs, as I do not want to inconvenience the next person by arriving more than an hour and a half early. It does however then mean that I have to keep myself occupied for the duration of the visit that has been cancelled. As I understand that emergencies do happen, I also realize that I cannot continue to manage these cancellations the way I have until the present. I have until now scheduled the cancellations in between the driving time from one Home Educators Day to the next. However, this quarter, due to the amount of cancellations, I was not able to schedule everyone in during the time available between Home Educators Days.

I travel approximately six thousand kilometers per quarter to service the home schools, and am not able to travel to home schools who cancelled their visits another time, due to a lack of time in my schedule, but also due to the financial implication it will have.

I would also like to keep the traveling times between Home Educators Days available for new home schools who joined after my schedule for the next quarter has been planned, and therefore cannot be visited because my traveling schedule for the assessment visits is already full.

I have sought some advice from a customer who home schools her children, but who is also a business woman. Her advice solves my challenge, and I am therefore going to implement this advice with immediate effect.

I will schedule two days each quarter during which home schools who cancelled their visits and who do not have an assessment, are then able to visit me at my home in Ceres. These homeschools will be required to call my telephone the PRECEDING Monday before the scheduled dates in order to set a fixed appointment.

This way I will be available for an alternative assessment visit. The applicable home schools will then have to do everything I normally assess at their homes with the

- Supervisor's Cards
- Goal Check Report Forms
- Goal Cards
- PACEs and tests completed since the last quarter
- CASS forms.
- Visit Report Forms.

Should these home schools decide not to visit me at my office, the specific quarter's assessment will then be **noted and documented as cancelled.**

I trust everyone will be able to understand my situation (and challenge) in solving this matter, and understand that these changes are indeed brought in to set things better, and at the same time take the pressure of my schedule to try to adapt an already full schedule.
