- Ensure that your CSAMS works properly NOW!!! Many home schools wait until the day the orders are due, and then find out that there are challenges with the program. This places unnecessary stress on yourself, and Etienne who then gets a lot of queries at once, and if they can't be sorted out in time, it places stress on me as the order that is emailed to me is then in the incorrect format, or incomplete. I then need to edit it on my side – which is a time consuming process.
