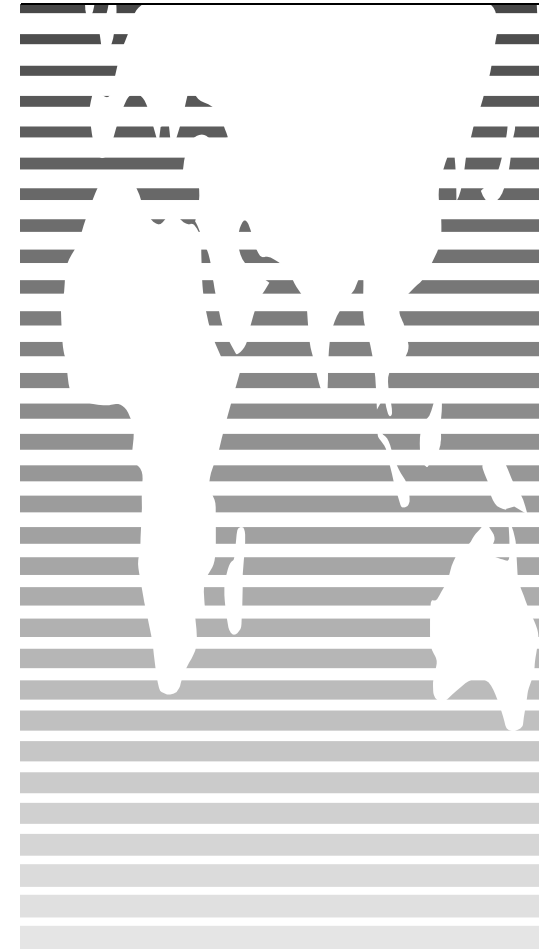

## C SAMS PROGRAM

During the last quarter, we have all probably done our best to implement the new C SAMS administration and ordering systems.

As is the case with just about every groundbreaking and pioneering

endeavor, there are challenges that surface, which allows us to fine tune and upgrade our efforts.

We also experienced this with the new C SAMS program and ordering file. However, many home schools have expressed their joy with the user friendliness of the final package as it is right now. Some home schools have mentioned that it is now much easier to order their curriculum and even keep their records updated.

Although the final idea is to have the program upload your students' PACE test scores onto the internet as they complete them, which will allow me to keep my records updated daily, this part of the program is still being fine tuned, and is thus not available yet.

I do encourage all home schools to ensure that they download the newest version of both the program and the ordering file in order to take advantage of the new changes that are being introduced from time to time.

## ACE STOCKTAKE !!!

You are probably aware of the fact that ACE's annual stock take takes place from 18 November until the end of the year. (Alert 32). The last orders that ACE will process for 2011 will thus have to be submitted to ACE by 12h00 on 15 November.
